Supply only

- 1. The Supply Only price includes detailing, cutting, bending and transport to site.
- 2. This quotation is valid for 30 days from the quotation date. Prices quoted exclude GST.
- 3. Payment in full is due on or before the 20th of the month following the month in which the goods are delivered.
- 4. This quotation is based on the Company's steel cost at the date of quotation. Any cost of steel increase due to circumstances beyond our control, between the quotation date and the supply date will be an additional charge.
- 5. Acceptance of any project by Nauhria Reinforcing Ltd is subject to suitable credit screening and credit arrangementsbeing agreed upon prior to commencement of any works.
- Acceptance of this quotation with the standard terms and conditions of Nauhria Reinforcing Ltd overrules all
 other contract documents sent to Nauhria Reinforcing Ltd unless such documents have been accepted in
 writing by Nauhria Reinforcing Ltd.
- 7. No retentions to be held.
- 8. "Pay when paid" or "paid if paid" clauses are not acceptable.
- 9. No allowance has been made for tie wire, chairs, spacers, rod pods, distribution steel, lifting eyes, bars welded to structural steel sections, threading, nuts, bolts, washers, drilling, grouting, inserts, couplers, welding, densotape or the like unless otherwise detailed in the quotation.
- 10. No allowance for lifting facilities on site.
- 11. Movement of supplied items from the truck drop-off point to the workplace shall be the responsibility of the head contractor. If performed by the steel placers, the time will be recorded and may be charged as a variation.
- 12. No allowance for siteworks, piles or precast unless specifically stated.
- 13. No allowance for engineers' inspections, tests or costs associated with the Building Act.
- 14. If revised drawings and /or site variations result in additional steel being required, it will be deemed as a variation and the contract price will be adjusted accordingly.
- 15. All and any variations must be in writing accompanied by an order number.
- 16. Contra charges will not be recognized unless advised, in writing, prior to any work commencing and that this work and resulting charges have been mutually agreed to. Nauhria Reinforcing Ltd must first be given the opportunity to rectify the reason for the proposed contra charges.
- 17. Reinforcing steel is a significant hazard. To minimize this hazard, please adhere to clause 10, item 2 of the Health and Safety in Employment Act.
- 18. Insufficient details/dimensions on the drawings will be the responsibility of the main contractor, to clarify prior to supply.
- 19. Minimum of 5 working days notice required for delivery to site, subject to a written order number and satisfactory construction drawings.
- 20. This quotation is based on reinforcing steel bars of Grade 300, Grade 300E and Grade 500E only. We will not be responsible for any costs associated with design or steel grade change.
- We reserve the right to invoice for excessive truck and/or steel placers waiting times for delays outside of our control.
- 22. Adequate access to and around the site, including adequate ground preparation, for delivery trucks must be provided. Nauhria Reinforcing Ltd takes no responsibility for inspection of access or ground preparation for delivery trucks.
- 23. Any contract arising from this quote will be under the Construction Contracts Act 2002.
- 24. Once a contract has been signed or the quote submitted has been accepted, no other subcontractor can contracted to conduct any work on the project under quotation/contract, unless agreed to by Nauhria Reinforcing Ltd.

Supply and Placing.

- 25. The *Placing Only* price includes placing the supplied reinforcing steel and mesh but does not include placing steel supplied for block work and steel to be grouted in.
- 26. Steel placers hours of work: Monday to Friday 7.30am to 5pm and Saturday 7.30am to 12 noon.
- 27. We require 5 working days notice to arrange for steel placers to be on-site to carry out the placing.
- 28. No responsibility will be accepted, if after placing, the reinforcing steel is displaced by another party.
- 29. Setout, scaffolding and hoisting to be provided by the Head Contractor for placing.
- 30. No allowance for bending of starters from panels/blockwork.

Cut, Bent and Fabricated into cages.

- 31. All pile cages are priced based on using maximum 12 meter stock length bars. Any changes to the length of cages, which cause additional waste or laps, will be charged extra.
- 32. No allowance for certified welding.
